# <u>Economic Development in Virginia – Roles and Responsibilities of Counties and IDAs</u>

Mr. Paul Jacobson, County Attorney, stated that last month the Board requested him to research and report on options available to counties in Virginia for the allocation of economic development duties and functions.

Virginia law authorizes a County to undertake activities to promote the County for economic development purposes. The County may accomplish this through a County economic development department. As with any other County department, economic development department staff would be under the supervision of the County Administrator.

Virginia law allows a county to provide funding for these promotional activities through a County economic development department or to the County's IDA. Many counties in Virginia promote economic development in the locality through a County economic development department. Counties that have established a County economic development department still use the County's IDA to accomplish projects that require IDA involvement, such as some capital project financing and economic development agreements.

The IDA is a separate entity from the County. However, Virginia law provides that the County Board of Supervisors is to appoint members of the IDA Board to four year

terms. According to county records the terms of three members of the Brunswick County

IDA Board end on June 30 of this year, and the Board of Supervisors will have the task of

appointing or reappointing persons to fill those three vacancies.

the Board voted to establish a county operated Department of Economic Development and

to transfer all proposed funds in the FY18 Budget for IDA to the newly established

Department of Economic Development.
