Year 2023 Real Estate Tax Relief for Senior Citizens or Permanently

and Totally Disabled Persons

Requirements:

Any applicant must meet the first 6 to qualify

• First-Time Filer, If totally disabled, must meet all 7 to qualify

Either

(a) At least one spouse must be 65 years old or older

(b) At least one spouse must be permanently and totally disabled

2. Total income *including* tax exempt income, of ALL residents of the dwelling cannot exceed \$50,000.00.

An exclusion of the first \$8,500.00 of income is allowed for each relative other than either spouse that is living in the dwelling.

- 3. Combined net financial worth of all residents in the dwelling cannot exceed \$150,000.00, not including the principal residence and up to one acre.
- If not a first time filer, a change in income could mean a change in the amount of tax relief you receive for that upcoming year in the program.
- 5. Applications must be filed between January 3 and April 3 of each year you are in the program.
- 6. Please provide income and asset verification including the first page of your 2022 federal return, if one was filed. No applications will be processed without copies of the required documentation.
- 7. First-Time filers who are permanently/totaly disabled: Please attach to your application a certification letter from two doctors or a copy of the Social Security Administration. First time filer applications must be mailed with the applicant's signature. Unsigned applications will be declined.
- 8. If you do not receive 100% tax relief you may inquire about the Real Estate Tax Deferral Program. Use the following link for more information: <a href="https://www.fcva.us/td">www.fcva.us/td</a>
